What is the purpose of this document?

This Cookie Notice gives a brief explanation of what cookies are and how we use them. It is important that you read this notice to understand the type of cookies we use, the information we collect using cookies and how that information is used. We may update this notice at any time.

What are cookies?

Cookies are small text files stored on the browser or your computer's hard drive. Cookies can be stored temporarily for a single session only, or longer if it is a persistent cookie.

Session cookies are deleted from your device when closing your browser. Persistent cookies will remain stored until deleted or until they reach their expiry date.

Cookies generally work to make your browsing experience as smooth as possible and are commonly used to maintain the state of a browser session.

How do we use cookies?

We use cookies to enhance your browsing experience by analysing how you use our site, which in turn helps us to troubleshoot any problems, monitor our own performance and provide users with the most commonly sought-after content.

We use the following cookies:

- Performance improvement cookies These allow us to track the number of visitors as well as monitor how they use our site. This helps us improve the site's overall navigation and the way the site works, by ensuring that users can find what they are looking for.
- Necessary cookies These cookies are required for the intended functionality of our site
 and are used to show the correct content at any given time. For example, on your first visit
 to our site, you will be shown a confirmation message regarding our use of cookies. Once
 accepted, a cookie is stored to tell us that we should not show this message anymore.
 Without these cookies, parts of our site may not work as intended.
